- 1. With respect to accommodation expenses from the 8th night through the 90th night, inclusive, up to USD \$125 / \$156\*, the expense will be allowed in full. If over USD \$125 / \$156\* per night, 75% will be allowed, but not less than USD \$125 / \$156\* for accommodation and not more than USD \$213 / \$266\* per night.
- 2. With respect to a trip that is longer than 90 nights: If the continuous stay in Israel between two or more trips overseas is less than 14 days - the trips will be regarded as one overseas trip and accommodation expenses of up to USD \$125 a night will be allowed.
- 3. The above rates are in effect for 2019.
